TERMS AND CONDITIONS

1. Rates quoted are in South African Rand and are per person per night and are inclusive of 14% VAT
2. All bookings must be made in writing with our Central Reservations office and all guests should be in possession of a valid booking confirmation obtained from our reservations office. A 50% non refundable deposit is required on confirmation of booking and balance should be paid prior to arrival.
3. A direct EFT deposit into our South African FNB account is preferred but payments can be made by Visa, MasterCard and Diners Club Card only or by electronic bank transfer. Cash can also be accepted to cover balance of payments and incidental costs. A 3% additional fee will be added for Credit Card transaction (Visa, MasterCard, and Diners Club Card only).
4. A **20%** loading applies from Christmas (18.12.09 – 03.01.10) Easter (01.04.10 – 06.04.10) and Soccer World Cup (11.06.10 – 11.07.10)
5. Room release time is at 18:00 hrs unless we are notified of a late arrival.
6. Normal Check-in time is 14.00PM and Check-out time 10.00AM; however we are flexible depending on our booking situation.
7. Cancellation more than 30 days prior to date of travel No Charge, Cancellation less than 30 days prior to arrival 25% Cancellation Fee, Cancellation less than 14 days prior to arrival 50% Cancellation Fee, Cancellation less than 7 days prior to arrival 100% Cancellation Fee
8. Children under 5 year stay for free. Children above 4 year pay the flat R 80 per head per night.
9. No person other than those quoted for, are permitted to share the accommodation.
10. A key and breakage deposit of R200 **CASH** is required on arrival when you receive the unit keys. The deposit is returned upon your departure, once the keys are returned and after a room inspection completed. We reserve the right to charge for any damaged items either wilfully or because reasonable precautions have not taken. House rules are available to read in the information booklets in the units.
11. During occupancy guests are required to maintain the unit in an orderly and tidy manner at all times. Any guests causing noise or nuisance to other guests, neighbors, management or unruly behavior within the National Park will be asked to leave. Management will not be liable to repay any compensation or refunds due to unruly guests being asked to leave early.
12. Noise should be kept to a minimum between 9.00PM and 8.00AM
13. National Park Adult Entrance fee per visitor per visit: 0 - 5yrs no charge, 6 -12yrs - R10, +12 yrs - R40 plus additional R10 per vehicle. **Cash** payment must be made on arrival at Park Entrance
14. No pets allowed at the river lodges as we are situated within a National Park.
15. Whilst every effort has been made with regards to your security and safety, Maliba River Lodge and it's owners are not liable for any losses, damages or injury of any nature by guests or their property on the premises.
16. The client who makes a booking thereby warrants his/her authority on behalf of all persons included in the booking to agree that all such persons shall be bound by the terms and conditions of listed on this website.
